4. Electronic bids must be submitted to the Sunil Smriti Rural Municipality, Office of Rural Municipal Executive Sulichaur, Rolpa through PPMO website www.bolpatra.gov.np/egp on or before 10 Feb. 2021 12:00 Hrs.
5. The Bid will be opened in the presence of Bidder's representative who choose to attend at 13:00 hrs 10 Feb. 2021 at the office of Sunil Smriti Rural Municipality Sulichaur, Rolpa. Bids must be valid for a period of 90 days after bid opening date and must be accompanied by a bid security or scanned copy of the bid security in PDF format, amounting to a minimum of as specified below which shall be valid for 30 days beyond the validity period of the bid after deadline for last date of Bid submission.
6. If the last date of purchasing and /or submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
